ORDER

Government vide Order read as first paper has accorded necessary sanction for setting up of Kerala State Land Bank in the office of the Land Revenue, Commissioner, with an outlay of Rs.3 crores (Rupees three crores only) (as against the plan outlay of Rs.5 crores). The amount allotted are for the following components:
