ORDER

For modernization of land records system in the country, a modified programme, viz, the National Land Records Modernisation Programme (NLRMP) has been formulated by the Department of Land Resources, Ministry of Rural Development, Government of India merging two centrally sponsored schemes of Computerization of Land Records (CLR) and Strengthening of Revenue Administration and Updation of Land Records (SRA & ULR). The State Governments/ Union Territory Administrations are the implementation authorities of the programme with the financial and technical support from the Department of Land Resources, Government of India.

2. The NLRMP is being implemented in the State through 3 authorities viz. Department of Revenue (100% CSS), Survey and Land Records (50% CSS & 100% CSS), and Department of Registration (25% CSS). The programme is highly technical in nature, and there is shortage of the requisite expertise. The Government of India in the letter read as first paper have directed to constitute Project Management Units (PMU's) in the form of registered societies at the State/ Union Territories level for the smooth implementation of NLRMP and has given draft guidelines for the purpose.

- 3. Once the PMU is constituted by the State, funds will be directly transferred to the Society from the Government of India. The unspent balance available with the State under the NLRMP will also be transferred to the PMU. The liability of the Central Government will be limited to hiring of consultants, programmers and supporting staff and the prescribed office expenses in the PMU during the period of implementation of the NLRMP only.
- 4. The Department of Land Revenue with its agencies like Kerala State Land Bank Project, Kerala Land Information Mission Project and the IT Cell, Revenue has been engaged in the field of land management, land records computerization and land survey. The Commissioner of Land Revenue in her letter read as 2nd paper above has forwarded proposal for constitution of the Land Governance Society of Kerala which will co-ordinate the functions of the above mentioned agencies.
- 5. Government have examined the matter in detail and are pleased to accord sanction for setting up of a Registered Society, under "Travancore Cochin Literary Scientific and Charitable Societies Registration Act" of 1955 called the "Land Governance Society of Kerala". The Society to begin with, will co-ordinate three projects, viz. Kerala State Land Bank Project, Kerala Land Information Mission Project and ReLIS (Revenue Land Information System) Project.
